

## CYBERNETIC EDUCATION — A NEW DEVELOPMENTAL WEAPON IN THE 21<sup>st</sup> CENTURY

### Abstract

A univalent, not multivalent, approach to the “concept” of strategic and geopolitical creation and management experiences a civilization twilight, i.e., a transitional discrepancy in the comprehension of cohabitation of education, development, and cohabitational dignity from an industrial to an informatical-technological 21<sup>st</sup>-century civilization, as a struggle of unnatural and natural transition generators, i.e., as a clash of the rich and the poor in the realization of the truth pertinent to a democratic, global, and market-oriented society.

The identification of a method and system for the registration of civilizational transitional ups and downs, as a new iconography of an ethical, evolutionary, and ecumenical equilibrium of the essence of life in the 21<sup>st</sup>-century informatical-technological civilization, becomes the topic of the work of the 2<sup>nd</sup> Pan-European forum, the *Croatia 2007 Symposium*, titled *Cybernetic Education — A New Developmental Weapon in the 21<sup>st</sup> Century*, i.e., in a struggle against the incubation and explosion of the proper, foreign, and natant parasitism viri.

The symposial Conclusion integrally promotes the role and importance of the “startup” strategy and geopolitics, as a new cybernetic-holistic etiquette and culture in an approach to the creation and management of a creative process in the 21<sup>st</sup>-century transition.

### 1. Natural and Unnatural Generators

We are the witnesses to a major national success and political contribution to a return of the Croatian nation's maternal community to the EC, emanating from the realization of the “root and the trunk” of the European civilizational circle pertai-

ning to the “Greek prudence, Roman law, and Christian faith,” but without a “proper” concept, structure, and content of a “startup” strategy, logistics, and discrepancy in the realization of the “natural and unnatural” transition generators, i.e., of the following:

- ratio and faith as the natural generators, emanating from the affluence of the European philosophical and theological heritage from the 1<sup>st</sup> to the 20<sup>th</sup> and for the 21<sup>st</sup> c., i.e., of a phylogenetic inheritable and inseparable DNA of the human and familial life, as an ethical, evolutionary, and ecumenical recognition sign of each nation and the European civilizational circle regarding the other global civilizations, whereby humanism becomes an inseparable metaphor of ethics, ecology an unapproachable metaphor of evolution, and a heritage identity’s continuity, not a global village clone, an untouchable metaphor of ecumenism;

- unnatural generators, i.e., the wars, social, economic, cultural, scientific, spiritual and linguistic colonialism, malign capital interest, power, prestige or a quagmire of the proper, foreign, and natant parasitism viri, emanating from an unnatural development of sociohistorical circumstances from the 16<sup>th</sup> to the 20<sup>th</sup> and for the 21<sup>st</sup> c. and the Croatian nation’s state-building organizations, i.e., a Europe-oriented Austro-Hungarian one in 1524, a Southern Slavic one in 1918, with a Greater Serbian denominator, a Croatian one in 1941, with the fascist and antifascist denominators, a Southern Slavic one in 1945, having a communist denominator, with a specially symbolic 1991 – 95 period, i.e., Croatia with a European and an authoritarian denominator, as a patriotic elite’s structural sin in the recognition of a transition from a self-governmental-communist to a democratic-capitalist society, i.e., of a redistribution of the Croatian nation’s “technological, employee, and proprietor” assets in a material and immaterial sense of a 20<sup>th</sup> – 21<sup>st</sup>-c. transition.

## 2. Civilizational Jump Registration

A selection of 200 Croatian families as the incumbents of the so-called “capitalist market-oriented transition” that should have reduced the rich and the poor discrepancy has resulted in an unprecedented unemployment, the Croatian men, family, nation and heritage indebtedness, and a catastrophic dissolutional twilight between the poor, mid-classed, and the rich, causing a necessity to redefine an approach to the theses pertinent to a patriotic recognition of an educational, developmental, and coexistential 2007 Croatia-EC dignity cohabitation, i.e., to identify the following:

- a new creative capabilities of the men and the family in the 1<sup>st</sup>, 2<sup>nd</sup>, and the 3<sup>rd</sup> life age;
- a new organization of the familial, fractal, and stockholders’ labor;

- a new role and significance of the “basic units” of the Pannonian and Mediterranean heritage of Slavonia, Baranja, and Sirmium, Central or Metropolitan Croatia, Istria, Croatian Littoral Region, Quarnero Bay and Dalmatia, as a quadruple 14-century-old regional sign of an economic, cultural, and spiritual recognition of the Croatian nation’s maternal community in the European and global civilizational circle, due to an explosion of new events in the bio-, ethno-, info- and nano-sphere and the malign impact of the proper, foreign, and natant parasitism viri in a patriotic comprehension of an educational, developmental, and coexistential dignity cohabitation from the 20<sup>th</sup> for the 21<sup>st</sup> c.

### **3. The Essence of Discrepancy in the Recognition of Natural and Unnatural Transitional Generators**

- a classical industrial civilization’s education, wherein the education is separated from the development and recognition of cohabitational dignity and a human biorhythm subordinated to a machine operation rhythm, i.e., wherein the material is superimposed over the spiritual and the sophisticated generates an incubation and explosion of the proper, foreign, and natant parasitism viri;

- a cybernetic-holistic education in an informatical-technological civilization, wherein the education becomes an inseparable part of development and cohabitational dignity due to the rapidity of the new technologies’ obsolescence, and, thanks to the new event explosion, a machine operational rhythm is programmed and subordinated to the human biorhythm, i.e., the spiritual, as an ethical, evolutionary, and ecumenical phenomenon of transitional generation and a sign of philosophical and theological recognition of a European civilizational circle concerning the other ones, becomes superimposed over the material, and the sophisticated inhibits the incubation and explosion of the proper, foreign, and natant parasitism viri.

### **4. A New Ethical, Evolutional, and Ecumenical Weapon for the Surmounting of the Gap: A Strategic and Geopolitical 3E-SBS21/CRO-EC 2007 Pilot Project**

The objective is the reorganization of a “classical” into a LLL cybernetic-holistic cohabitational system of education, development, and coexistential dignity comprehension, i.e., an education and graduate and postgraduate examination and theses’ design as a part of the pilot project, aiming at an increase in the number of highly educated population from 7 to the 15% European minimum and implying an identification of 150,000 new natural-familial incumbents of a technological, employee, and proprietary surmount of the 3E GNP developmental gap from US\$ 4,000 to 20,000 per capita up to 2015 in the five Slavonia, Baranja, and Sirmium counties, pursuant to the Bologna Declaration, Lisbon Agreements, and the ECST system, while incorporating a new role and significance of a regional university as a logistics and seminary for transitional generation.

## **5. Conclusion - National Program of a Regional Development, Logistics, and EC Approach Strategy for Five 3E-SBS21/CRO-EC 2007 Slavonia, Baranja, and Sirmium Counties examinee sample: City of Osijek and Osijek-Baranja County**

A proposal for a county-based nostrification of a new ethical, evolutionary, and ecumenical weapon for the design of an educational, developmental, and coexistential dignity strategy and geopolitics of the five Slavonia, Baranja, and Sirmium counties ensues from a scientifically accepted and valorized Pan-European pilot project titled *Cybernetic Education — A New Developmental Weapon in the 21<sup>st</sup> Century*, as a matrix for a national developmental strategy, logistics, and an ontological basis model for negotiations concerning the EC accession, i.e., as a message and work conclusion of the 2<sup>nd</sup> Pan-European symposium *Croatia 2007*, held in Osijek on December 1, 2004.

## **6. Confirmation of the Role and Conclusive Significance: An Invitation to the 2004-15 Cooperation**

The nonexistence of a national startup strategy and geopolitics and its infrastructure, i.e., a method and system for the registration of civilizational transitional ups and downs, a matrix for a national and European coexistential model, databank, incubator, stock exchange, a Copyright and Intellectual Right Agency, a European Normization Agency and a symposium on a continuous scientific and ecumenical valorization of the parts and the entirety of the pilot project as a national and European logistics and seminary, i.e., the establishment of the *3E-SBS21/CRO-EC Cybernetic-Holistic Academy, Inc.* prior to the commencement of the EC accession negotiations, is a scientifically inadmissible ethical, ecumenical, political and patriotic fault, detrimental to the Croatian men, family, nation and heritage, i.e., to the essence of life, sovereignty and sustainable equilibrium, thus becoming a common challenge and a basis for a cooperational invitation regarding the design, promotion, and nostrification of the pilot project in the County Assemblies, Ministries, Government, and the Republic of Croatia's Parliament.
