

Pursuant to Article 16, paragraph 1 and Article 25 of the Statute of the Faculty of Economics and Business within the Josip Juraj Strossmayer University of Osijek, and in accordance with the Decision of the Senate on the organisational units of the scientific/artistic-teaching components of the Josip Juraj Strossmayer University of Osijek of 25 September 2019 (CLASS: 602-04/19-06/6, REG.NO.: 2158-60-01-19-4), the Faculty Council of the Faculty of Economics and Business within the Josip Juraj Strossmayer University of Osijek (hereinafter: the Faculty Council) at the 10th session of the Faculty Council in the academic year 2024/2025 held on 10 September 2025, under agenda item 5, hereby issues the

DECISION
on the Organisation of the Faculty of Economics and Business
within the Josip Juraj Strossmayer University of Osijek
in the Academic Year 2025/2026

I.

The organisational units of the Faculty are: departments, centers, library, and the secretariat.

II.

The department is the basic organisational unit of the Faculty for the performance of teaching, scientific and professional work, which is usually established for several related subjects. The Department does not have any lower organisational units in its composition.

There are six departments at the Faculty, as follows:

-On the basis of the Consent of the Josip Juraj Strossmayer University of Osijek (CLASS: 112-02/24-02/3, REG.NO.: 2158-60-01-25-72) and the Consent of the Ministry of Science, Education and Youth (CLASS: 602-04/25-04/00102, REG.NO.: 533-04-25-0008), a public competition was announced in the Official Gazette 117/25 for the election of one male or female employee for the vacant teaching position of lecturer in the scientific area of Social Sciences, the scientific field of Kinesiology for an indefinite period and full-time employment at the Faculty of Economics Faculty within the Josip Juraj Strossmayer University of Osijek, which is expected to be completed in October 2025, and the elected employee will be a member of the Department of Interdisciplinary Courses.

The UNESCO Chair for Entrepreneurship is established at the Faculty as a separate organisational unit of the Faculty on the basis of an agreement signed between The United Nations Educational, Scientific and Cultural Organisation and the Josip Juraj Strossmayer University of Osijek on 18 February 2008.

III.
